## About IKS Division

Home to the oldest continuously living civilization of the world, the Indian subcontinent was the knowledge and manufacturing powerhouse of the world for most of the known history. A Dharmic culture that emphasized the development of all dimensions of humanity with an emphasis on living in harmony with oneself, one's environment, and the universe at large. It is becoming very apparent with the recent developments around the world that the current models of development are unsustainable and are in direct conflict with nature. The rising inequalities around the world in capitalist systems and the failure of communist/socialist economics point to a dire need for new paradigms of development.

*There is an Indian way that is both sustainable and strives for the welfare of all. If we want to become the Knowledge Leader in this century and be the 'Viśva guru', it is imperative that we understand our heritage and teach the word the 'Indian way' of doing things. Therefore, the IKS Division of Ministry of Education was established with a vision to **promote interdisciplinary and transdisciplinary research on all aspects of Indian Knowledge Systems (IKS), preserve and disseminate IKS knowledge for further research, and societal applications.***

### Functions of IKS division:

- 1) Facilitate and coordinate the interdisciplinary work done by various institutions in India and abroad including Universities, institutions of national importance, R&D laboratories and different ministries.
- 2) Establish, guide and monitor subject wise interdisciplinary research groups comprising of researchers from institutes and centers and individuals.
- 3) Create and promote popularization schemes.
- 4) Facilitate funding of various projects and develop mechanisms to undertake research.

## Overview of the (BG Samvahan Karyakram-3) Program

There is a strong need to promote IKS in the country in traditional schools and STEM educational institutes which will be addressed by this initiative. ***The IKS Internship program is designed to encourage and enthuse youth to take up deeper study of various topics related to IKS preferably in Bharatiya Bhashas.*** The focus is to create opportunities for students to contribute and be involved in active research during the summer breaks or anytime during the year. Therefore, the IKS division is continuing the institutional internship program called भारतीयज्ञानसंवाहनकार्यक्रम:-3 (BG Samvahan Karyakram-3). Additionally, the charge of the IKS division is to help in the implementation of the NEP 2020.

This internship program is for organizations to host the interns for IKS projects with clear deliverables. The organizations are expected to submit proposals to the IKS division describing the IKS project, requirements for interns (Specified in terms of person months) and the deliverables from the project. The proposals will be evaluated by a team of experts and the selected projects will be funded for performing the proposed work through interns at their institution. The projects are required to have clear quantifiable deliverables to be considered in the review process. The selection process of the interns along with the requirements for the minimum and preferable qualifications will be completely managed by the awardee organization as per the requirements of the project. Internship duration can be up to six months or the duration of the project.

**Nature of outputs expected from this program:** The deliverables of this program must support the IKS division in implementation of NEP 2020 in the area of IKS. The priority is to create materials such as course material, reference material, digital media and multimedia resources, hands-on activities, materials for curriculums of school education and undergraduate education. These materials should be in a form that could be used by textbook writers for direct incorporation into the textbooks at school and undergraduate level. Creation of digital repositories curating the art wok including pictures, sketches, art work, multimedia including cartoons, graphics for use in the Textbooks/ IKS community, and oral traditions of Bharat is a priority.

Please note that the IKS Division will retain the right for using/disseminating all the materials created and curated in various internship projects without paying any further royalties. The contributing authors will maintain their authorship of all the documents, but copyright will be with the IKS division. The intention is to put all the materials from this program in the public domain for free access by all.

The differences between the previous internship programs of the IKS division and this Internship program are described in the Table 1.

**Nature of Support:** Each intern will be awarded a stipend (@ 10,000/month) for the duration of internship. The awardee organization will be provided with Rs. 2,500/person-month to manage the internship process. These funds can be used to fund the honorariums of the PIs, Co-PIs, and experts (Maximum of Rs. 1.00 lakh for the duration of the project), purchasing supplies, and any other costs associated with the internship projects.

## **Eligibility Criteria/Preparation and Submission Instructions**

Mentors can choose any areas as per their specialization but the focus must be a IKS domain. ***Projects that are only marginally related to the IKS themes and are without substantial IKS content will be rejected*** (please see the note 1 regarding what does/does not qualify as a valid IKS project). Please make sure while selecting the number of interns, that your valuable time will definitely be available to them.

**Eligibility:** The IKS is inviting proposals from organizations working in the Indian Knowledge Systems. Faculty members in any Govt. recognized educational institutions (private/public), Govt. funded labs and NGOs/Trusts/foundations, acharya's in any gurukula or pathashala, practicing artists with a minimum of 5 years' experience in teaching and learning are eligible to be the principal investigators. To be eligible for this grant, NGOs/Trusts/foundations must be ***solely working*** in the research and education related to Indian Knowledge Systems.

**Independent researchers without an institutional affiliation or students currently pursuing any degree are not eligible to apply as principal investigator.**

Each project must identify a list of mentors who will work directly with the interns. The principal investigator is expected to be assisted by a team of mentors with domain expertise.

**Expectations from the mentors:** The mentors are expected to spend 3-4 hours per week or more as needed to introduce the IKS project to the intern and provide references to literature that the intern is expected to know thoroughly understand. The interns will work with the mentor to conduct the literature search, experiments, field visits as per the project requirements. The mentors will help the interns in the preparation of the progress and final reporting by providing editorial oversight for factual correctness of the information in the report. In case of non-performance of the specified work by the interns, mentor is expected to report to the IKS division by email detailing the issue so that necessary action including the termination of the internship can be pursued.

**Recognition for Mentors:** Mentors are the key to the success of the BG Samvahan Karyakram-3 program. We highly respect your passion and are grateful for selflessly spending your time and effort to teach the younger generation about the IKS. Mentors will be recognized with a certificate from the IKS Division.

Funding projects with clear deliverables that will help in the IKS Division's mission to support the implementation of NEP 2020 is our top priority. When proposals are similarly scored, we give preference to Principal Investigators who are Acharya's in traditional gurukula's/pathshalas, practicing artists, assistant professors, associate professors and professors (in this order). **An institute can submit only one IKS internship proposal. If multiple IKS internship proposals are received from an institute, all proposals will be rejected without review.** The proposal can be submitted in any Indian Language included in the Eighth Schedule or English.

**Project Description:** The project description must consist of a brief background of the topic, relevance to the IKS Division mission, clear and specific goals, clearly specified measurable outputs, and the expected number of hours an intern is required to spend to complete the project. Projects that have clear goals and specific measurable outputs and are relevant to the IKS area will be given preference for selection.

1. The proposal should focus on describing how it will support the IKS Division's effort to support the implementation of NEP 2020.
2. Maximum duration of the projects is six months.
3. Joint (multi institutional) and interdisciplinary projects are preferred, and encouraged.
4. All projects must be **completed before 15<sup>th</sup> November, 2023**. Extensions will not be granted.
5. **Proposal deadline is 11:59 p.m. 15<sup>th</sup> May, 2023 and must be submitted through online portal (iksindia.org) only. Any other form of submissions will not be considered. *Late proposals will not be accepted for any reason.***
6. IKS Division reserves the right to nominate proposals to the review panel that further the IKS Division's mission as determined by internal review. The nominated proposals will be considered on an equal basis and will undergo the same peer review process as other proposals.
7. Awards will be announced, and funds will be available in June 2023.
8. Final reports are due 30<sup>th</sup> November, 2023. ***The honorariums for the project PIs, coPIs and the last month stipend to students will be released only after the submission of the final reports and completions of the documentation.***
9. IKS division requests that a no more than 300-word layperson language summary (Suitable for publicly posting on the webpage) and several photos of your work be submitted with each report. These may be used in IKS's annual report or on our website.
10. Please prepare the proposal as per the proposal guidelines given below. Failure to follow these proposal guidelines will result in your proposal not being reviewed or funded.
  - a. Please use the proposal template provided. If you use the version at the end of this document, you will need to adjust pagination and margins. Proposals that do not follow the template will be rejected without review. There will be no further communication entertained if the proposal does not follow the template provided.

- b. Use the signature page provided and make it a separate page in your document.
- c. Complete the cover page provided. Make it a separate page in your document.
- d. The proposal body with appropriate references should not be more than ten (10) pages long. Please write your proposal in clear simple language and do not list references unless you cite them.
- e. Use 1-inch margins on all sides, single line spacing, at least 11-point font.
- f. Please place page numbers at bottom center of the pages.
- g. A complete proposal includes the following documents:
  - i. Document 1: Cover page
  - ii. Document 2: Proposal narrative
  - iii. Document 3: Budget page
  - iv. Document 4: PI and CoPI resumes
  - v. Document 5: PI signature and institutional approval pages
- h. Please submit all of them as a Single pdf documents only. You can use any of the pdf merge tools available for free online (ex. <https://www.adobe.com/in/acrobat/online/merge-pdf.html> or <https://smallpdf.com/merge-pdf>)
- i. Whole document file must be <100MB.
- j. Once your proposal is finalized, save as a PDF file using this naming format YOURLASTNAME\_BG Samvahan Karyakram-3. If you are submitting two proposals, add a suffix identifier to each file name, i.e., YOURLASTNAME\_ BG SamvahanKaryakram-3\_projectname
- k. The above naming convention must be strictly followed.
- l. Incomplete submissions will be rejected without review.***

#### 11. Submission Process

- b. Upload your PDF proposal file (<100 MB) and then press the submit button
- c. If your submission has been successful in the web system, a notification will be sent within two days informing you of the successful submission. If you submitted a proposal but do not receive such notice, please contact the IKS.

#### 12. Budget Distribution

- a. The project funds for will be sanctioned in two installments. The first installment will consist of the intern's fellowship amounts. The second installment after the submission of all deliverables and documentation will consist of the honorariums to the PI, Co-PIs and Collaborators and the last month stipend for the students.
- b. Proposals proposing more than the budget limit (15.0 lakhs or 120 person months) will be returned without review and automatically excluded from the review process. There will be no further communication in this regard.
- c. Funding will be provided to support the following
  - i. **Salary** for project personnel/project associates/research fellowships/interns.

- ii. **Honorariums:** The principal Investigator will be paid an honorarium of 1.00 lakhs/year. In case of Co-PIs or Collaborators, the honorarium of Rs. 1.5 Lakhs/year will be divided equally among them up to a maximum of Rs. 0.5 Lakhs/year- Co-PI or Collaborator. No other type of honorariums will be accepted for PIs/Co-PIs/Collaborators. The honorarium amounts will be released only after completion of all the deliverables of the project.
  - iii. **Supplies:** includes equipment with an individual piece value less than ₹10,000, i.e. ten temperature sensors or chemical bottles at ₹1000 each are still considered to be supplies. Any service charges for the analysis of samples can be included in this budget head.
  - iv. **Equipment/Facilities:** No equipment is allowed under this project.
  - v. **Travel and conferences:** Travel is allowed only for field visits and other data collection. Any travel to attend domestic/international conferences is explicitly not allowed. The maximum allowable travel and conference expenses are 20% of the total budget.
  - vi. **Contingencies:** Maximum contingency allowed is 5% of the total budget.
  - vii. **Overhead:** No overheads are allowed under this project.
- d. **Matching grants:** While not mandatory, institutional support through matching grants or any other financial or in-kind support is encouraged to leverage the scant resources of the IKS division. Please indicate monetary and in-kind support from other sources for this project.

### 13. Post Award processes

- a. The funds will be disbursed in two installments. IKS division will make every effort to disburse the funds at the earliest subject to the submission of necessary documents by the PIs.
- b. IKS Division reserves the right to review any project by an external expert committee at any time during the project. IKS Division reserves the right to cancel the project if there is no progress in the project as determined by the committee report. The decision of the IKS Division will be final and binding in this regard. The institute will have to return the unspent funds of the project with accumulated interest to the IKS Division.

Guidelines for the projects: The projects must strictly be related to IKS themes. Projects must have clear scope that can be completed by interns in six months. The projects must have clear quantifiable deliverables. Writing a comprehensive report is required for all projects. For projects that involve performing arts, a comprehensive multimedia documentation is expected.

Note 1\* For the purposes of this program, IKS is defined as the systematized knowledge that is created by Indians in Indian subcontinent over the millennia and has been transmitted through



oral traditions, manuscripts, texts, and traditional practices. The IKS exists in all Bharatiya Bhashas in multiple forms. Projects must have significant input of the traditional knowledge. Significant input here means that the project must involve a study of the primary or secondary sources of IKS related literature. Project solely based on modern knowledge systems and modern scientific methods and analysis do not qualify as IKS projects. However, use of modern scientific analysis and tools to study IKS literature is highly encouraged. See the Table 2 below for specific examples.

**Table 2. Examples of what qualify/do not qualify as an IKS project**

## Proposal Review Criteria

The following criteria will be used by the reviewers of your proposal to evaluate and rank your proposal against others. Please think about these questions carefully and answer them clearly in your proposal using the proposal structure specified.

- Are the implementation plan and goals clearly stated and **understandable**? (10 points)
- Is this project **relevant** to IKS Division's mission and focus areas? (20 points)
- Does the project lead to creation of substantial and **significant** resources for use in the NEP2020 implementation? (20 points)
- Will the results of this study be **useful**? Might they **make a difference**? What are the **economic/environmental/social** benefits of the outputs of this project? (15 points)
- Does the proposed **intern requirement seem appropriate** for the work to be executed in the project? (10 points)
- Does the PI and the team have necessary competence, prior experience and expertise to undertake the proposed project? (25 points)

Strength of the proposal (up to 100 words): Please list the specific strengths of the proposal.

Weakness of the proposal (up to 100 words): Please list the specific weaknesses of the proposal if any.

NOTwithstanding the weaknesses do you think that there are some specific reasons due to which the project may still be considered for support?

Summary Statement (up to 100 words): Please indicate whether this proposal should be supported or not.

- **Translated primary texts and Secondary References:** These pertain to the translations of the primary texts into various languages including English. Secondary references refer to the texts/articles such as commentaries for the primary texts.
- **Other references:** All other pertinent references are included here.
